### - Stewart of Garth -

**ORIGIN.** The Stewarts of Garth are descended from James Stewart, one of the natural sons of Sir Alexander 5tewart, Earl of Buchan and Lord of Badenoch, fourth son of King Robert II. He *m.* to Janet, only daughter and heiress of Sir Alexander Menzies of Fortingall, second son of Sir Robert Menzies of Weem, (she resigned her lands of Fortingall in favour of Sir Alexander Stewart, her father-in-law on 28 October, 1379/80<sup>1</sup>), with whom he acquired these lands and is styled as brother to Alexander Stewart, Earl of Mar, in a charter dated 24 December, 1409. He was father of,

- 1. Neil Stewart, a member of an assise in 1428.
- 2. John Gorm Stewart, one of the Atholl men who captured the assassins of King James I. in 1437, and was killed in conflict with Sir William de Ruthven at the North Inch of Perth on 24 June, 1443.<sup>2</sup>

**NEIL STEWART, OF FORTINGALL,** a member of an assise at the court of Dunkeld in 1428 to determine the rights of JohnMacNab to the lands of Bovain. He was father of,

- 1. John Stewart, of Fothergill or Fortingall, (see below).
- 2. David Stewart, witness to an Instrument of Sasine following upon a Precept from the Chancery for the lands of Easter and Wester Duntallich in favour of John Stewart, Earl of Atholl, on 28 March, 1474,<sup>3</sup> and is said to have been father of.
  - 2a} John Stewart, said to have been father of,4
    - 2b} Robert Stewart, 1st of Fincastle and Urrard, (see Stewart of Fincastle).
    - 2b} Alexander Stewart, 1st of Balnakeilly and Foss, (see Stewart of Foss).
    - 2b} John Stewart, 1st of Innerkynnachan, obtained these lands and had issue from which descended the first family of Kynnachan.
- 3. Neil Stewart, m. to Elizabeth Gordon and is styled as brother of John Stewart of Garth in 1478.
- 4. A daughter, m. to Patrick de Rattray, of that Ilk, (he d. on 4 October, 1461,) and had issue.

John Stewart, 3<sup>RD</sup> of Fothergill or Fortingall, had a Crown Charter for these lands on 30 October, 1455,<sup>5</sup> and had a charter for the lands of Killibroath and Disert in the Earldom of Atholl from Andrew, Lord Gray, on 23 August, 1462.<sup>6</sup> He acquired the lands of Edradynate from John Stewart, Earl of Atholl, on 24 July, 1465, and had a charter from Alexander Stewart, of Grantully, for the lands of Pitcairn, lying in the Barony of Appin of Dull, on 2 December, 1465.<sup>7</sup> He had a charter from Sir John de Ogilvy of Lintrethin for the lands of Tillicurran, Dalgarne and Glennatay, with the fortalice thereof, lying in the Lordship of Strathardill on 7 October, 1470,<sup>8</sup> and had a charter for the lands of Strathardill from David Ogilvy of Inchmartin on 28 April, 1473.<sup>9</sup> He *m.* to a woman by the name of Marion, *d.* on 10 December, 1475,<sup>10</sup> and was father of,

- 1. Neil Stewart, 4th of Fortingall, (see below).
- 2. Alexander Stewart, 1<sup>st</sup> of Bonskeid, had a charter for the lands of Bonskeid from his father on 31 December, 1474, and *d.* in 1501. He had issue *(see Stewart of Bonskeid).*
- 3. James Stewart, styled as brother german to the deceased Neil Stewart of Garth when he was appointed one of the procurators to Alexander Stewart, brother of Thomas Stewart of Grantully, in a dispute with Agnes Murray, Lady Grantully, over the rights to the lands of the lands of Petcairns on 21 July, 1501.<sup>11</sup>

NEIL STEWART, 4<sup>TH</sup> OF FORTINGALL, had a charter of confirmation of the lands and lordship of Appin of Dull, Glenquaich, Glenlyon, Strathbraan and Rannoch, for the space of 19 years under the Great Seal of King James III. on 24 January, 1478, and in which he is styled as son and heir to the deceased John Stewart of Fothergill.<sup>12</sup> He *m.* to Elizabeth, daughter of Alexander Stewart, 3<sup>rd</sup> of Grantully, with whom he had a charter of confirmation of the lands of Bordland of Fortingall (Fothergill), Tullichmoulin, Artaskat, Drummacharry and Ewquhirblaris, all lying in the barony of Fortingall, following upon a resignation by Neil for a charter of joint-infeftment on 22 August, 1495.<sup>13</sup> He *d.* on 31 January, 1499, <sup>14</sup> and was father of,

- 1. Alexander Stewart, the eldest son, concerning whom his father entered into a contract with John Stewart, Earl of Atholl, on 22 January, 1477, that his said father would become "man" to the Earl in return for for his bestowing his eldest son Alexander Stewart in marriage with Christian Stewart, daughter of the John, Earl of Atholl, and in the event of the death of Alexander then he would give his next son Neil Stewart. <sup>15</sup> He *dsp*.
- 2. Neil Stewart, 5<sup>th</sup> of Fortingall, (see below).
- 3. John Stewart, in Duntaullich, (see Stewart of Duntaullich and Drumcharry).

NEIL STEWART, 5<sup>TM</sup> OF FORTINGALL, infeft as heir to his deceased father in the lands of Fortingal on 5 June, 1500, <sup>16</sup> and burned Weem Castle in July of 1503. <sup>17</sup> He had a charter of confirmation under the Great Seal of King James IV. for the lands of Bowrek, Leyduyk, Lassintullich, Tullochresk, Kynseathane, Pitdorny, Uchterblaris, and the Mains of Fortingall all lying within the barony of Fortingall on 1 March, 1505. <sup>18</sup> He resigned his lands of Fortingall with the castle and fortalice thereof with the lands of Pitdorny, Tullichcurren and Dalnagarn in favour of Alexander Gordon, Earl of Huntly, who had a charter of confirmation under the Great Seal of King James IV. on 25 March, 1506, in which he is styled as son and heir of the deceased Neil Stewart of Fothergill. <sup>19</sup> He *m.* firstly by 1 March, 1505, to Christian, daughter of John Stewart, 1<sup>st</sup> Earl of Atholl, (she *d.* on 1 June, 1538, and was buried at Dull<sup>20</sup>) and secondly to Mariote MacQueen whom he is said to have murdered by pushing from the cliffs at Garth in 1545. He *d.* in 1554 and was father of,

- 1. John Stewart, of Bunrannoch, (see below).
- 2. Marie Stewart, retoured heir to her brother John Stewart and her father Neil Stewart in the lands of Calziebroachan on 29 July, 1577.<sup>21</sup>

**JOHN STEWART, OF BUNRANNOCH**, infeft in the lands of Calziebrochan as heir to Neil Stewart of Fortingall, his father, on 30 January, 1557,<sup>22</sup> and *dsp* by drowning in 1577.<sup>23</sup>

### - STEWART OF BONSKEID -

**ORIGIN**. The Stewarts of Bonskeid are descended from Alexander Stewart, younger son of John Stewart, 3<sup>rd</sup> of Fortingall, who had a charter from his father for the lands of Bonskeid on 31 December, 1474. He was father of,

**ROBERT STEWART, 2<sup>ND</sup> OF BONSKEID**, had a Precept for these lands as heir to his father on 19 May, 1501, and assisted his cousin Neil Stewart, of Fortingall in the burning of Weem Castle in July of 1503. He *d.* in the first months of 1546 and was father of,

**James Stewart, 3<sup>RD</sup> of Bonskeid,** had a Precept for these lands as heir to his father on 7 July, 1546, and *m.* to Janet, daughter of James Stewart, of Fincastle. He *d.* on 16 October, 1565, and was father of,

JOHN STEWART, 4<sup>TH</sup> OF BONSKEID, had a charter for these lands from his father on 12 June, 1563, and *m.* to Margaret, only daughter and heiress of Alexander Stewart, 1<sup>st</sup> of Carse. He was killed in 1606 by Alexander Stewart MacGillecallum<sup>25</sup> and was father of.

**ALEXANDER STEWART, 5™ OF BONSKEID,** had Sasine following on a Precept as heir to his father on 1 June, 1607, subscribed a bond for reset of the Clan Gregor on 8 October, 1621, and *m.* to Margaret, daughter of Alexander Robertson, 8<sup>th</sup> of Lude, (she was divorced from her first husband Robert Robertson, second son of George Robertson, of Faskally,) to whom he granted an Instrument of Sasine for the lands of Bunrannoch on 7 September, 1610.<sup>26</sup> He was father of,

- 1. John Stewart, 6th of Bonskeid, (see below).
- 2. James Stewart, 1<sup>st</sup> of Wester Cluny, had a charter from his father for the lands of Wester Cluny on 29 May, 1625, in which he is styled as his second son<sup>27</sup> and *m.* to Barbara, daughter of Duncan Menzies, of Comrie. He was father of,
  - 2a} Alexander Stewart, 2<sup>nd</sup> of Wester Cluny, *bap.* at Wester Clunie on 24 June, 1639, and had and Instrument of Sasine from his father for the lands of Wester Cluny on 3 July, 1667. He *m.* firstly in 1667 to Catherine, daughter of Duncan Campbell, 2<sup>nd</sup> of Lagvinsheoch and Monzie, and secondly to Isabel, daughter of John Stewart, fiar of Balnakellie, (*c/m* at Dunkeld on 20 December, 1680,<sup>28</sup>). He had issue,
    - 2b} James Stewart, 3<sup>rd</sup> of Wester Cluny, succeeded his father and was appointed Minister of Moulin. He *m.* at Moulin on 12 August, 1709, to Elizabeth, daughter of Colin Campbell, 4<sup>th</sup> of Monzie, and *d.* in 1735. He was father of,
      - 2c} James Stewart, 4<sup>th</sup> of Wester Cluny, *b.* in around 1712 and was appointed Minister of Kilbrandon. He *m.* firstly on 21 July, 1750, to Marjory, daughter of Campbell, of Ardchattan, (she *d.* on 16 January, 1754), and secondly on 20 February, 1759, to Elizabeth, daughter of Lachlan MacLachlan, of Fassifern, and *d.* on 27 May, 1787. He had issue,
        - 2d} Patrick Stewart, b. on 27 September, 1751, and d. on 7 May, 1759.
        - 2d} Marjory Stewart, *b.* on 14<sup>th</sup> and *c.* at Kilbrandon on 29 January, 1754, and *m.* to Neil Campbell, of Lotterie.
        - 2d} James Stewart, c. at Kilbrandon on 18 July, 1760, and d. on 15 August, 1761.

ROBERT STEWART, 1<sup>ST</sup> OF FINCASTLE, obtained these lands, m. to Agnes Gray and by whom he was father of,

- 2. John Stewart, ancestor of the Stewarts of Urrard, (see Stewart of Urrard).

James Stewart, 2<sup>ND</sup> of Fincastle, witness to an Instrument of Sasine for all and whole of the Earldom of Atholl in favour of John Stewart, Earl of Atholl, on 28 September, 1579,<sup>75</sup> succeeded his father in these lands and *d*. on 15 April, 1590. He had issue,

- 2a} John Stewart, fiar of Ladywell, who was beheaded at Edinburgh on 28 July, 1641, for having accussed the Earl of Argyll and other Covenanters of holding a meeting at the Point of Lyon to dispossess King Charles I. He *m.* to Anne Clerk and had issue,
  - 2b} Thomas Stewart, 2<sup>nd</sup> of Ladywell, succeeded his father and married firstly to Margaret, daughter of John Graham, 3<sup>rd</sup> of Balgowan, (*c/m* 25 and 26 January, 1660, with her Tocher being £3000<sup>82</sup>). He *m.* secondly after February of 1676, to Jean, daughter of David Drummond, 2<sup>nd</sup> of Innermay, (she was widow of William Oliphant, of Culteucher, by whom she had issue).     - 2c} Elizabeth Stewart, styled as daughter of Thomas of Ladywell in a Sasine dated 1699.
    - 2c} Amelia Stewart, a daughter by her father's second marriage who *m*. to John MacEwen, Writer in Dunkeld. She was infeft in her half-brother John Stewart's estate as his heir on 27 October, 1713.<sup>85</sup> They had issue.

He *m.* in 1589 to Margaret, daughter of Patrick Stewart, of Ballechin, *d.* between October of 1621 and 5 January, 1627, and was father of,

He *m.* firstly at Moulin on 13 January, 1752, to Ann, second daughter of Alexander Robertson, of Faskally, (she *d.* by 8 April, 1755, <sup>146</sup>) by whom he had no issue; and secondly at Moulin on 6 February, 1766, to Elizabeth, daughter of John Robertson, of Tullybelton, (*c/m* 10 February, 1766, <sup>147</sup>) and *d.* by 14 September, 1782. - 2. Alexander Stewart, against whom letters were raised for his having killed John Stewart of Bonskeid and is then styled as "Alexander Stewart McGilliechallum." He was brought to justice for his many crimes and executed in 1607.

- 3. John Stewart, more popularly known as "John Dow McGilliechallum" or "Black John the son of Malcolm" who, with his brother Alexander, was a turbulent force within Atholl. They were pursued by the Privy Council for being "fugitives and outlawis for vyld and abominable murthouris and otheris odious crimes" in 1606. Matters had escalated to such an extent that the Privy Council pursued "the Baron Reade" Alexander Tarlochson of Inchmagranoch and Neil Stewart McGilliechallum, John's his brother, for having reset and entertained him and bound the Earl of Atholl, to apprehend he and his accomplices and bring order back to his lands but which he could not manage and as a result of which he was put to the horn and ordered to commit himself in ward to Edinburgh Castle as a penalty until the offenders had been brought to justice. In 1607, although his brother Alexander had been captured and executed, John still remained at large with a considerable force of armed men and a commission was granted to James Gordon, younger of Lesmore, to pass to Atholl and seek him out with sanctions being given for he use of hagbuts and pistols although this also was to no avail. Later in 1607 commissions were granted to the Stewart of Grantully, Ballechin, Kinnaird and Foss to form a Watch and to bring peace to Atholl which appears to have been successful. He *d.* probably by violence by 1620 and was father of,
  - 3a} Robert Stewart, named as being occupant with his cousin George Stewart of Bohespick on the lands Ardandeor in a charter for these lands by William, Earl of Tulliebardine, in favour of George Nasmyth of Leduckie in 1620.<sup>149</sup>
- 4. George Stewart, 1<sup>st</sup> of Urquhillbeg, obtained these lands of from John Stewart of Foss and in which he was infeft on 26 April, 1594. <sup>150</sup> He *d.* prior to 7 April, 1629, and had issue,

    - 4b} Neil Stewart, 3<sup>rd</sup> of Urquhillbeg, infeft in the lands of Urquhillbeg on 7 September, 1699,<sup>154</sup> and *m*. to Jean, eldest daughter of Andrew Rattray, of Tullochcurran, (*c/m* 12 December, 1672,<sup>155</sup>). He was father of,
      - 4d} Alexander Stewart, 4<sup>th</sup> of Urquhillbeg, infeft in the lands of Urquhillbeg following upon a resignation in his favour by his father on 6 October, 1699, <sup>156</sup> and was father of,
        - 4e} Walter Stewart, 5<sup>th</sup> of Urquhillbeg, infeft in the lands of Urquhillbeg on 14 October, 1736, <sup>157</sup> and served as a Captain in the Atholl Brigade of the Jacobite army during the uprising of 1746/46. He *m.* at Moulin on 1 June, 1736, to Marjory, daughter of Captain Archibald Menzies, of Culdares, (*c/m* 1 June, 1736, <sup>158</sup>). He was father of,
          - 4f} Archibald Stewart, 6<sup>th</sup> of Urquhillbeg, infeft as heir to his father in the lands of Urquhillbeg on 8 July, 1773,<sup>159</sup> and diponed these lands to his brother-in-law Donald MacDuff, Mercant in Dunkeld, on 31 March, 1777.<sup>160</sup>

**Neil Stewart of Sheirglass,** is the first to appear in record as possessor of the lands of Sheirglass and as son of Malcolm Stewart in Urquhill Blaris, he was witness to a charter by John Robertson, *alias* Tarlochson of Monzie, in favour of his spouse Christian Oliphant, relict of George Robertson, of Faskally, for the liferent of his lands of Easter and Wester Monzie in implementation of a contract of marriage on 12 May, 1596. He was put to the horn by the Privy Council for having reset his brother John dow McGilliechallum in 1606, and is then styled as Neil Stewart McGilliechallum, obtained the lands of Bohespick from Alexander Stewart MacThomas, son of Thomas Stewart, 1st of Kinnaird, on 16 October, 1612, 164 and *m.* to Elizabeth Robertson. He was father of,

- 1. John Stewart, of Sheirglass, (see below).
- 2. George Stewart, of Bohespick, infeft in the lands of Bohespick by Alexander Robertson of Inchmagranoch on 8 June, 1621, and is then styled as second son of Neil Stewart of Sheirglass. He *m.* to Margaret, sister of Donald Robertson, Tutor of Struan, (*c/m* at Kirkton of Blair Atholl on 5 January, 1642, 166) and *dsp* prior to 5 December, 1662, when his brother John Stewart of Sheirglass, was retoured his heir. 167

**DONALD STEWART, OF SHEIRGLASS,** infeft in the lands of Sheirglass on 28 February, 1706, and was witness to the contract of marriage between Neil Stewart, brother of John Stewart, of Bonskeid, and Giles, eldest daughter of John Stewart of Dalguise on 20 April, 1710.<sup>178</sup> He *m.* to Dorothy, daughter of John Stewart, 7<sup>th</sup> of Bonskeid, (*c/m* 25 June, 1696,<sup>179</sup>) and *d.* prior to November of 1737. **Donald Stewart, of Sheirglass,** *c.* at Dull on 21 July, 1731, succeeded his father and *m.* at Dull on 8 August, 1756, to Sophia, daughter of John Stewart, younger of Bonskeid, (*c/m* 19 August, 1756,). He had the misfortune to inadvertently kill his brother-in-law John Stewart of Bonskeid, at an Inn in Moulin where both had retired too following a visit to a local market on 20 October, 1767. It is said that Sheirglass was so drunk that he cut his lip while eating cheese with his dirk. In a fit of rage at the laughter at his expense he lashed out and caught the unfortunate Bonskeid under the chin killing him. He was

John Stewart, 3<sup>RD</sup> OF Foss and Meikle Granich, appears with his father as witness to an Instrument of Sasine for all and whole of the Earldom of Atholl in favour of John Stewart, Earl of Atholl, on 28 September, 1579,<sup>219</sup> and had a charter of confrmation for the lands of Foss from John Stewart, Earl of Atholl, in 1584 wherein he is designed son to Neil Stewart of Foss. He obtained the lands of Wester Granich from George Robertson, of Easter Granich, in which he was infeft on 3 May, 1605,<sup>220</sup> was witness to a Bond of Caution by James Stewart, Earl of Atholl, Robert, and William Stewart his uncles, not to harm James Stewart of Ladywell on 6 October, 1603, and *m.* to Isabel, daughter of Patrick Stewart, 1<sup>st</sup> of Ballechin. He was father of,

- 9b} Robert Stewart, 3<sup>rd</sup> of Garth, *b.* in 1740 and *m.* at Dull on 27 September, 1765, to Janet, eldest daughter and coheiress of David Stewart, 2<sup>nd</sup> of Kynnachan, (she was served heir to her father on 16 June, 1768). He *d.* on 26 October, 1820, and had issue,
  - 9c} William Stewart, 4<sup>th</sup> of Garth, *bap.* at Dull on 25 October, 1766, and was served heir to his father in the lands of Garth on 5 March, 1821. He was served heir to his "grand uncle" Patrick Stewart of Drumcharry in the lands of Drumcharry on 11 December, 1820, and *d.* without legitimate issue on 26 July, 1822.<sup>297</sup> He was father of,
    - 9d} Betty Stewart, a natural daughter by Mary MacGregor who was *bap.* at Fortingall on 29 November, 1795.
  - 9c} David Stewart, 5<sup>th</sup> of Garth, *b.* in 1772, attained the rank of Major-General in the army and *d.* unmarried at St Lucia on 18 December, 1829. He was father of,
    - 9d} Neil Stewart, a natural son who was apprenticed onboard a Merchant ship trading with West Indies. He was a gentleman's servant in Edinburgh by 1837.
    - 9d} Jean Stewart, a natural daughter by Christian MacLean who was *c*. at Fortingall on 23 December, 1823.
  - 9c} John Stewart, *bap.* at Dull on 16 August, 1777, was a Planter in the West Indies for many years and *d.* in 1832. He was father of several natural children,
    - 9d} John Stewart, a natural son who resided with his brothers in the West Indies. All are named in a letter the family attorney in West Indies, John Losh, concerning their wish to have their legacies of £100 paid by the family back in Scotland.

    - 9d} David Stewart,
    - 9d} Robert Stewart,
    - 9d} Ann Stewart, a natural daughter by Charlotte Tobin, "a free couloured woman," who was *bap.* at Grenada on 17 March, 1810. She came back to Scotland with her father in 1823 and lived with her relations, the Irvines at Craigatin where she *d.* unmarried in 1859.
  - 9c} Alexander Stewart, a natural son by Elizabeth MacGregor who was *bap.* at Fortingal on 6 December, 1789.
  - 9c} Janet Stewart, served heir to her father on 23 June, 1834, and to her brother John Stewart on 29 August, 1836, and to her brother General David Stewart in the lands of Garth on 27 October, 1830. She *m.* on 3 April, 1805, to Alexander Irvine, Minister at Little Dunkeld, (he *d.* on 31 July, 1824), and *d.* on 18 March, 1865. They had issue,
    - 9d} Alexander Robertson Irvine, *b.* at Fortingall on 20 January, 1806, and was appointed Minister of Blair-Atholl. He *m.* firstly on 2 June, 1833, to Margaret, daughter of Joseph Stewart-Menzies, 11<sup>th</sup> of Foss, (she was *c.* at Dull on 15 December, 1809, and *d.* on 22 January, 1836), and secondly at Blair Atholl on 24 September, 1844, to Sophia Jane Stewart, daughter and heiress of Captain Duncan Robertson, of Kindrochit, (she *d.* on 25 January, 1856). He *d.* on 2 September, 1867, and had issue,
      - 9e} Elizabeth MacKenzie Menzies Irvine, the only child by her father's first marriage and was *c.* at Dull on 15 May, 1834. She *m.* to Francis Garden Fraser, of Findrack, (he *d.* in December of 1883), and *d.* on 31 January, 1911. They had issue.
      - 9e} Alexander Irvine, c. at Blair Atholl on 20 August, 1842.
      - 9e} Duncan Robertson Irvine, c. at Blair Atholl on 14 May, 1851.
      - 9e} Robert William Irvine, c. at Blair Atholl on 31 October, 1853.
      - 9e} Sophia Stewart Robertson Irvine, c. at Blair Atholl on 22 September, 1845.
      - 9e} Clementina Janet Irvine, c. at Blair Atholl on 20 June, 1849.

  - 9b} Charles Stewart, c. at Fortingall on 10 January, 1756.
  - 9b} Betty Stewart, *c.* at Foss on 18 December, 1752, and granted a reciept for board to her cousin Robert Stewart of Garth in 1767.
  - 9b} Mary Stewart, c. at Fortingall on 21 March, 1759.
  - 9b} Christian Stewart, c. at Fortingall on 10 September, 1761.
- 9a} Neil Stewart, c. at Balquhidder on 17 October, 1728, is styled as third son of Robert Stewart of Garth in 1757 when he granted Letters of factory to Robert Stewart of Garth as he had joined Montgomery Regiment of Foot. He had issue,
  - 9b} Charles Stewart, a natural son by Isabel MacDonald who was *c.* at Fortingal on 15 November, 1749. His father agreed in 1757 to pay maintenance until he reached the age of 18.

**PATRICK STEWART, 4<sup>TH</sup> OF DRUMCHARRY,** had a Disposition from his father for the lands of Wester Drumcharry on 15 June, 1670, in which he is styled as his only son<sup>308</sup> and whom he succeeded by 7 February, 1699, when he raised Letters of Caption against John Robertson of Guay. He *m.* firstly to Isabel,

daughter to Robert Fleming, 4<sup>th</sup> of Moness, and had issue; and secondly to Janet, eldest daughter of Donald Robertson, of Eastertyre, (*c/m* 3 November, 1685,<sup>309</sup>) and was father of,

- 1. William Stewart, 5<sup>th</sup> of Drumcharry, (see below).
- 2. Charles Stewart, of Inchgarth, apprenticed to Charles Stewart, Merchant in Perth, on 2 June, 1704, and was served heir provisional to his brother Patrick Stewart in the lands of Drumcharry by his father on 27 November, 1710, and is then styled as second and youngest son to his father. He obtained the lands of Inchgarth in around 1733, *m.* to Helen, daughter of Charles Stewart, of Rotmell, (she was widow of Alexander Stewart, 5<sup>th</sup> of Findoynet, whom she had *m.* by *c/m* 27 January, 1702,<sup>310</sup> and by whom she had issue), and *d.* in 1765 and prior to 23 September of that year.<sup>311</sup> He was father of,
  - 2a} James Stewart, younger of Inchgarth, served as an Officer in the Atholl Brigade of the Jacobite army in 1745 and was *ksp* at the battle of Culloden on 16 April, 1746.

- 3. Isabel Stewart, m. to John Stewart, son of Neil Stewart, in Auchmore, (c/m 9 February, 1705<sup>314</sup>), and had issue.

WILLIAM STEWART, 5<sup>™</sup> OF DRUMCHARRY, had a Disposition from his father for the lands of Wester Drumcharry on 27 November, 1710, and for which he had a Charter of Confirmation under the Great Seal on 12 February, 1711. He *m.* at Auchtermuchty on 25 December, 1713, to Mary, daughter of John Moncrieff, of Mornipy, *d.* in 1766<sup>315</sup> and was father of,

- 1. Patrick Stewart, 6th of Drumcharry, (see below).
- 2. Ann Stewart, to whom her brother Patrick Stewart of Drumcharry granted a Disposition for the lands of Drumcharry in 1775.<sup>316</sup>
- 3. Mary Stewart, mentioned with her sister in a Bond by their father in favour of Sir Robert Menzies and reffered to at a later date in 1780,<sup>317</sup> and *m*. to James Rattray, in Blackcraig.
- 4. Jean Stewart, *m*. to William Stewart, 2<sup>nd</sup> of Garth, (*c/m* 27 December, 1738. He was widow of Grissell, daughter of John Scrimgeour, whom he had *m*. at Dull on 17 August, 1736,. He *d*. in 1756) and had issue.

PATRICK STEWART, **6**<sup>TH</sup> OF DRUMCHARRY, had a Disposition for the lands of Drumcharry from his father to be held by himself and his heirs, whom failing, by Robert Stewart of Garth and his heirs on 24 June, 1761,<sup>318</sup> and *dsp* in June of 1776.<sup>319</sup>
